	Compulsory sits and Foundation courses	Year 11 students currently enrolled in Foundation course units must sit in Semester 1. Students who achieve a Category 3 result in a Semester 1 window are not eligible to continue in the associated Foundation course units in Semester 2. 	Two sits per year for Years 11 and 12	To ensure Year 11 and 12 students get their two sits per year, schools should ensure that students sit in at least one of the Semester 1 windows.

	Multi-Factor Authentication (MFA) for the OLNA Dashboard	New users will need to follow the steps in the 'Using the OLNA Dashboard' section within the <i>OLNA Dashboard User Guide</i> available at https://senior-secondary.scsa.wa.edu.au/assessment/olna/schools . Previous users who are logging in for the first time in 2024, will be required to re-link their MFA account. To re-link your account, follow the steps in the attached <i>Assessment Master MFA Re-linking account (for iOS and Android)</i> document.

	Cohorts	Years 10–12 students are eligible to sit in this window.
	Adjustments	New or changed adjustment (disability and EAL/D) requests for Year 10–12 students must be entered into the OLNA Dashboard by 4.00 pm Thursday, 23 May 2024.
	Student Login Details	<i>LAN002 – OLNA Student Login Details</i> report will be available via SIRS on Tuesday, 4 June 2024. This report lists the usernames and passwords of students eligible to sit the upcoming OLNA window.
	Testing location	All students sitting an OLNA component must do so at the school where they are enrolled. The use of anonymiser technology (such as a VPN or Tor) that potentially obscures the location of the student is not permitted.
	Devices	Schools are responsible for ensuring that all applications including writing tools such as Grammarly® and typing settings are turned off or not available during the OLNA. Students who are found with any of these applications or typing settings running may have their test result cancelled.
