- (a) Custodianship of Country (2 marks)

Answers could include: Custodianship of Country refers to Australian First Nations Peoples' ongoing relationship with their lands and to the reciprocal relationship with Country, rather than ownership over the lands. This includes the rights, duties and obligations to care for Country, as defined through kinship roles and language groups. These are passed on through traditions. Accept other relevant answers.	

- (b) World view (2 marks)

Answers could include:	
<p>Weather: Australian First Nations Peoples 'read' the stars and watch the movements of the planets to predict coming weather and shifts in seasons. For example, the Mer people from the Torres Strait Islands use natural markers to indicate the coming monsoon season. Understanding the weather also enabled Australian First Nations Peoples to make decisions such as when to hold ceremonies, plant new crops or harvest existing ones, travel, for their communities based on incoming shifts in weather and seasons.</p>	
<p>Links to ancestors: Astronomy provides Australian First Nations Peoples with links to the Dreaming and knowledge of ancestors, which is shared through oral traditions. For example, the ancestors return in the movements of individual or groups of stars, the planets and/or the dark spaces in the sky.</p>	
<p>Navigation: Many constellations have been used by First Nations Peoples to help with travelling distances across land and waters. The patterns of the stars represented routes of travel on the land, with each star in a constellation corresponding to specific landmarks such as waterholes, laying out a shape that can be remembered when travelling.</p>

The Kimberley Land Council (KLC)

Background: formed in 1978 as a political land rights organisation, it has evolved to now work with Aboriginal people to secure native title recognition, conduct conservation and land management activities and develop cultural business enterprises.

Reasons for the establishment: of the KLC was set up to ensure the protection of the region was prioritised through Native Title recognition. For more than 44 years, the KLC has worked to protect land, law, language and culture, and has succeeded in securing native title rights across roughly 97 per cent of the Kimberley.

Answers could include:	
<p>Economic benefit:</p> <ul style="list-style-type: none"> • Kimberley Land Council – have grown to be one of the biggest employers in the Kimberley across many towns and remote communities. Through employment opportunities and pursuing cultural enterprise development the group seeks to improve the socioeconomic outcomes of First Nations People in the Kimberley through economic empowerment. Developing and creating locally envisioned and owned economic opportunities is being worked on through building capacity and skills of people to participate in their own economy. 	
<p>Environmental benefit:</p> <ul style="list-style-type: none"> • Kimberley Land Council – have worked with Indigenous land managers since 1998. All environmental protection actions are informed by the cultural values of the Indigenous peoples. Benefits to the environment have been seen through programs that have seen traditional knowledge transfer from older to younger generations, fire management and biodiversity research and protection. These practices are protecting and enhancing the natural resources of the Kimberley environment.

<p>The Kimberley Land Council's (KLC) benefits to culture and identity can be seen in enhancing and celebrating the cultural, spiritual and social connection to Country that exists for First Nations Peoples. Through valuing the knowledge of the First Nations Peoples, cultural empowerment and strengthening identities can be seen. The KLC also works to facilitate the maintenance and promotion of Aboriginal Law and Culture, Community Health and Wellbeing, Heritage Protection, Cultural Law and Practice, Traditional Language and Cultural Expression.</p>

Answers could include:

Both the Kimberley Land Council and the Danjoo Kooliny Walking Together Project have important social benefits for the communities in which they are located. Both organisations work hard to educate the wider Australian public about cultural awareness.

Danjoo Kooringal Walking Together Project

- Danjoo Kooringal Walking Together Towards 2029 and beyond has a strong focus on guiding people and organisations on their journey of cultural awareness and reconciliation.
- Danjoo Kooringal is working for a change in society, including reversing the effects of systemic racism, historic injustice and intergenerational trauma.
- The project also works hard to reinvigorate Aboriginal led arts and cultural events in the community, such as the 'Shining the light; Yarning together performance which was part of the City of Perth's Australia Day festival.

The Kimberley Land Council (KLC)

- The KLC supports the Kimberley Aboriginal people in using their cultural values to enrich the natural environment, deliver employment and training, ignite social change, support carbon abatement, and stimulate economic activities in their communities.
- It provides opportunities for Aboriginal women to become rangers. The increased participation of women in ranger teams has solidified the importance of women's cultural knowledge of plants and animals. Women rangers are also helping with the important maintenance and preservation of cultural sites.
- It is also delivering social and cultural benefits in local schools through an innovative two-way science program launched in 2022, which sees rangers working with schools to bring learning on-country.

Answers could include:

Australian society:

The Aboriginal land and sea management ranger work delivers social, cultural and economic benefits at multiple scales. These benefits include:

- Aboriginal ranger programs are effective and cost-effective and when rangers work on Country, they experience personal benefits, including increased skills and confidence, and better health and wellbeing.
- Community members benefit directly from ranger activities, with the reassurance that Country is being cared for, and opportunities are realised for the transfer and preservation of cultural knowledge.
- The broader community has greater understanding of, and respect for, traditional ecological knowledge.
- Rangers and community members report that there is less violence, resulting in safer communities.

The ranger programs provide employment opportunities for women and networking opportunities with other ranger groups, partners and environmental managers, resulting in enhanced management efforts and the development of regional enterprise opportunities.

Environment:

Aboriginal ranger programs may provide benefits such as:

- biodiversity conservation
- fire management
- restoration of wetlands
- weed control
- feral animal control
- care of waterways.

The Dugong and Marine Turtle project is an example.
